Any extra entertainment done at OCP, i.e. petting zoo, inflatables, pony rides, etc.? _____ If so, a Certificate of Liability Insurance naming Carrollwood Recreation District as an additional insured is required from the vendor with a minimum of \$1,000,000 in coverage. The applicant must also provide a copy of their homeowners' insurance declarations page with at least \$300,000 in liability coverage. These certificates of insurance must be received in the office at least 3 days prior to the event.

Rules and Regulations

The CRD has established the following rules and regulations to keep the facilities in good and safe condition for all residents. Violation of the Rules and Regulations may result in the loss of privileges to use the parks.

1. _____ The key to the park is issued to the resident and is **not to be transferred to another resident or non-resident. Violation of this rule may result in the suspension of park privileges.**
2. _____ **No Alcohol or Animals are allowed in any of the parks,** except the dog run area in Original Carrollwood Park. Violation of this rule may result in the suspension of park privileges.
3. _____ Resident is responsible for the clean up of the park. Please bring trash bags with you for the event and take them home with you. Please dispose of cigarette butts properly. Failure to clean up the area may require a security deposit for future use.
4. _____ Please make sure the restrooms are locked when you leave the facility. Keys may be purchased for \$10.00 from the Rec Center on Monday through Friday from 9:00 AM to 1:00 PM. One key fits the park restrooms at White Sands Beach, Scotty Cooper Park and the Rec Center restroom.
5. _____ Parking for Original Carrollwood Park (OCP) is available at the Rec Center, no parking is allowed at OCP or on Phoenix Circle. No motorized vehicles are allowed in the park.
6. _____ All parks close at dusk. Please make sure that your activities have concluded and that the area is clean before leaving.
7. _____ An additional deposit is required for any inflatables used at OCP. \$50.00 - damage deposit for the pavilion. \$200.00 - damage deposit for the inflatable. \$75.00 - key deposit for the service gate key.

White Sands Beach – The rules listed below also apply:

1. _____ For your safety, do not swim in the boating area. It is dangerous with the boat traffic. Violation of this rule may result in the loss of Beach privileges.
2. _____ No guest boats permitted. Only boats with current CRD stickers are allowed to use Lake Carroll. All other boats are considering trespassing and may result in arrest – **Fl. Statute 810.09. No keys are to be transferred to another resident or non-resident. Violation of this rule may result in the loss of Beach privileges.**
3. _____ Boat Ramp gates are not to be opened for Barges or dock work without prior written permission from the CCA and the CRD. Violators will lose their Beach privileges and the unauthorized user will be considered trespassing and may be subject to arrest. (Fl. Statue 810.09).

The person who signs the CRD application for park reservation and then violates a material provision of the rules which that person has agreed to, in writing, will be subject to the following:

A. _____ LIQUIDATED DAMAGES FOR VIOLATION OF CRD RULES. THE UNDERSIGNED APPLICANT HEREBY SPECIFICALLY AND KNOWINGLY AGREES THAT IF THE APPLICANT OR THE APPLICANT'S AGENTS, GUESTS OR CHILDREN MATERIALLY VIOLATE ANY OF THE CRD RULES WHICH ARE SET FORTHIN THIS APPLICATION, THEN THE APPLICANT HEREBY AGREES TO PERSONALLY PAY AND BE RESPONSIBLE FOR THE PAYMENT OF A \$500.00 LIQUIDATED DAMAGES CLAUSE ONLY APPLIES TO THE EVENT OF MATERIALLY VIOLATING A RULE AND DOES NOT OTHERWISE LIMIT THE CRD'S RIGHT TO SEEK ANY OTHER DAMAGES WHICH THE CRD MIGHT INCUR AS A RESULT OF THE APPLICANT'S USE OF THE CRD'S RECREATIONAL PARKS, LANDS OR FACILITIES.

B. _____ ATTORNEY'S FEES AND COSTS. THE UNDERSIGNED APPLICANT SPECIFICALLY AGREES TO PAY ALL OF THE CRD'S REASONABLE ATTORNEY'S FEES AND COSTS WHICH ARE INCURRED BY THE CRD IN ENFORCING THIS AGREEMENT OR WHICH OTHERWISE INCURRED BY THE CRD IN ANY ACTION ARISING OUT OF THIS AGREEMENT OR A MATERIAL VIOLATION OF THE CRD'S RULES OR ARISING OUT OF ANY ACT WHICH CAUSES DAMAGES TO THE CRD'S PROPERTY OR CAUSES DAMAGES TO ANY PERSON OR AJOINING THE CRD'S PROPERTIES. THE UNDERSIGNED APPLICANT SPECIFICALLY AGREES TO PAY A MINIMUM ATTORNEY'S FEES OF AT LEAST \$500.00 PLUS ALL COURT COSTS AND FILING FEES AND ALL OTHER RESONABLE COSTS, FOR ANY LEGAL ACTION BROUGHT BY THE CRD UNDER THIS AGREEMENT OR BROUGHT BY ANY OTHER PERSON WHICH RELATES TO THE ENFORCEMENT OF ANY CRD RIGHT OR ANY CLAIM AGAINST THE CRD UNDER THIS AGREEMENT.
