The Carrollwood Recreation District (CRD) is an independent special district created by the Florida Legislature in 1973. In order to serve on the nine-member Board, a "Qualified Elector" must file to run for office every two years with the Hillsborough County Supervisor of Elections. While this is a non-compensated position, each candidate for office pays a \$25 filing fee (or) submits 25-candidate petition forms. After the November general election is over, the newly elected members pay \$10 to the Department of State to receive the required credentials. In addition, board members are required to file annual financial disclosures with the State of Florida, along with complying with other statutory requirements.

As of March 10, more than 40 candidates have taken the first step toward being on the 2018 ballot by filing to run for county and local offices in Hillsborough County. That period of time between when a contract offer has been completely signed by both parties



and when it closes is fraught with risk. During that time, for all practical purposes, your house is off the market. Under MLS changes instituted in the past year, once a house is under contract, it can no longer be listed as "Active." It must now be classified as "Pending" which essentially takes it off the Realtor's radar.

So what are all these contingencies that must be dealt with? First is the financing contingencies. Typically, a Realtor will pre-qualify potential buyers by being sure they have a "pre-approval" letter from a mortgage lender. Usually the buyer calls a lending institution and over the phone they will give them their financial history, but how complete and accurate is that data? There's always a caveat at the end of the pre-approval letter stipulating that this is no guarantee that the buyer referenced is qualified. The loan is never really approved until the underwriter puts their stamp of approval on the package. Sometimes that happens on closing day and sometimes it doesn't

happen at all. Now you have lost all of that time and you start over again. By the way, the chances are that you WILL NOT end up with the escrow deposit. If there is financing involved the standard contracts all say, "This contract is contingent on buyer obtaining approval" "30 days (or more) after the effective date."

In the "AS-IS" contract, Section 12 is the "Property Inspection: Right to Cancel" clause which allows the buyer the option of canceling the contract during that inspection period by "buyer's sole discretion." This time is usually 15 days, but the buyer could ask for more or the seller could demand less.

There is also the appraisal contingency. There is a separate document just for this activity, but even without that document, if the appraisal didn't meet the selling price, it could also be cause for the buyer to get out of the contract unless the seller is willing to re-negotiate the price.

Admittedly, these things do not happen often but they DO happen. You

must be diligent throughout the pending period with your listing agent to be certain that the mortgage process is moving along. They are limited as to how much information they are privy to because of the Dodd-Frank Act, however, nothing prevents them from asking questions.

My recommendation, as always, is for you to READ THE CONTRACT. Make sure your Realtor has gone over the contract paragraph by paragraph. This takes time and is extremely boring for most people but it is still most likely the biggest single investment in your life. Treat it as such.
