Public Hearing Notice

Proposal to Change Carrollwood Recreation District Tax

The Board of Trustees of the Carrollwood Recreation District, a Florida independent special district, will hold a public hearing on Monday, April 11, 2022, at 6:30 p.m. This public hearing is open to the public and will be held at the Carrollwood Recreation Center, 3515 McFarland Road, Tampa, FL 33618.

The purpose of the public hearing is to consider placing a referendum on the August 23, 2022 ballot proposing to change the maximum annual assessment of the Carrollwood Recreation District Tax. This existing assessment is a non-ad valorem annual assessment imposed on each individual improved residential parcel located within the boundaries of the District, that's purpose is to fund the financial needs of the District. The current maximum annual assessment that may be imposed by the District is \$600 per each improved residential parcel within the District. The proposed change would increase the maximum annual assessment that could be imposed to \$1,200 for each improved residential parcel within the District.

If approved by a majority of those voting in a referendum, the District in its annual budgeting process could consider imposing the Carrollwood Recreation District Tax in any amount up to the approved maximum per residential parcel of \$1,200 per year. The assessment would be levied against each improved residential parcel, both single family homes and townhomes, once every year after its approval. The assessment will be collected by the Hillsborough County Tax Collector. Failure to pay the assessment will cause a tax certificate to be issued against the subject property, which may result in a loss of title to that property, pursuant to the requirements of Florida law. All affected property owners have a right to appear at the meeting and to file written objections with the District within 20 days of the date of this notice. Written objections may be mailed to 3515 McFarland Road, Tampa, FL 33618 or emailed to office@originalcarrollwoodcrd.com, or delivered by hand at the public meeting. Public comment will also be allowed at the public hearing, limited to three minutes per speaker. A letter from The Carrollwood Recreation District Board

Even A Small Leak Will Sink A Great Ship.

A Bit Of History

On December 5, 1972, the Florida Legislature approved a referendum creating the **Carrollwood Recreation District (CRD)**, a Special District responsible for providing essential government services and facilities within a limited geographical area. The CRD has a volunteer Board of nine Trustees that run for public election every two years. Operating under the authority of the Government in the Sunshine Act of 1976, the Board may only discuss and vote on District business at public meetings, the dates of which are advertised as Public Notices in the newspaper.

How The CRD Board Works

As a Special District, CRD budgets are subject to yearly audits which are sent to the State Controller, Hillsborough County Clerk of the Circuit Court, Auditor General, and the Department of Community Affairs. More notably, the CRD Board is beholden and accountable to the residents of Original Carrollwood, and therefore, no budget is approved without presenting it publicly to you — our constituents — first.

Remaining Solvent Against Inflation

On April 12, 2021, long before gas prices were over \$4.00 per gallon, before inflation reached a 40 year high of 7.9%, Board Trustee Michael Carelli expressed concerns regarding CRD budget projections (as recorded in the CRD Board public meeting minutes). This was the first of many discussions the Board had over a course of months regarding our fiscal responsibility to the future of Original Carrollwood. As a hedge against this growing tide, the Board managed, as always, a fiscally tight and responsible budget while continuing needed maintenance, repairs, and requested neighborhood improvements. By December of 2021, additional budget forecasts predicted that the District would run at a deficit within five years and that raising the annual assessment was paramount to maintain a balanced budget — as required by the State of Florida.

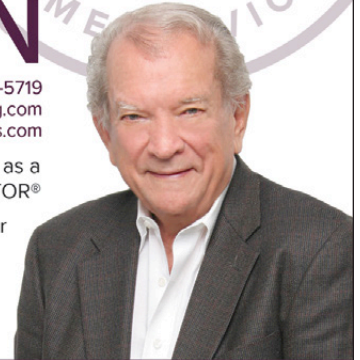

FLOOD INFORMATION

Protecting the resident's safety is a high priority for Hillsborough County Government.

Anywhere it rains, it can flood. A heavy afternoon downpour can turn into a life-threatening and financially devastating flood in the blink of an eye. Hurricanes and tropical storms increase the danger from flooding.

Therefore, the County is encouraging all property owners in Hillsborough County to understand their risk for flooding and to purchase flood insurance. Remember, homeowner's insurance does not cover water damage from flooding. Only flood insurance covers water damage to your property from a flood or storm surge.

Most people know that properties near the Gulf of Mexico or Tampa Bay need flood insurance due to their elevated risk for storm surge flooding. As a matter of fact, flood insurance is required by mortgage lenders for most of these property owners.

Hillsborough County has worked hard on your behalf to reduce those rates by adopting proactive floodplain management requirements to reduce flood risk across the County. This approach has

earned residents a flood insurance discounts of 25 percent.

Hillsborough County understands that insurance is a complicated topic. Don't let a flood wipe away everything for which you've worked so hard. Get flood insurance.

Find out your flood risk. Hillsborough County offers a free flood map information service so that you can find out if your property is in a high, moderate or low risk flood zone or a floodway, and your hurricane evacuation zone. Remember flood zones and evacuation zones are different! This webpage will let you look up the flood zone of your property. <https://arcg.is/0HHD5G10>

The following webpage will locate the evacuation zone and provide other good information for hurricane preparedness. <https://bit.ly/3BPaz6Q>

You can also see if you live near protected areas that have natural floodplain functions, like wetlands, swamps or mangrove stands. These areas store flood waters or buffer wave action while providing habitat for wildlife and cleaning the flood water.

Hillsborough County is a participating community in the Federal Emergency Management Agency's (FEMA's) National Flood Insurance Program (NFIP). Furthermore, since October of 1992, the County has taken advantage of the opportunity to participate in the NFIP's Community Rating System, or CRS. The CRS program incentivizes communities to go above and beyond minimum standards to implement best practices that better protect the community from flooding.

REAL ESTATE 101: SPECIAL ASSESSMENTS

I talk about contracts a lot because there are many nuances that people don't pay attention to but need to. Most of my clients prefer to glance over the contract as quickly as possible and then sign. As hard as it is for some to

pay attention, I still insist on them understanding THOROUGHLY what they are signing. For example, under Section 9, Paragraph f, you have the label Special Assessments. There are two choices. Seller pays all outstanding assessment or seller pays assessments up to the date of sale and buyer picks them up after date of sale.

If a buyers agent wants to give benefit to his clients they may check the box calling for seller to close out any Special Assessments. The seller may think they don't have any, but often there are sewer repair assessments or open CDC's in new developments which you only see on the tax statement. Most have a lifespan so you are paying those on time. A subdivision when built may have had a modest

assessment of \$300 per year in tax. If that was for 20 years and the house was built in 2010, then you still have nine years to go because taxes are always paid in arrears. That could be a \$2,400 hit that you didn't anticipate.

So you need to make sure that area is looked at carefully. There are many "fill in the blank" areas in the contract that are followed with the statement "if left blank then X number of days will be used." I personally don't like to use that option so I always fill in these blanks. They may not seem like much but often those items affect other parts of the contract which could affect whether or not you can get the Escrow deposit or not.

In essence, my suggestion to you is "READ THE CONTRACT." Every last word of it. It's legally binding and it has hundreds of thousands of dollars worth of impact.

A letter from The Carrollwood Recreation District Board



Where Does The Money Go?

The budget is based on the assessment of \$600 per residence per year and any income from rentals, versus projected costs, including utilities, ground maintenance, irrigation, ongoing payment of debt, insurance, and facilities' maintenance and repair, all of which amount to a budget of \$620,017 per year. (For a detailed budget, visit www.originalcarrollwoodcrd.com).

While we continue to maintain a balanced budget, we are beginning to put "band-aides" on some maintenance issues for lack of funds to maintain our record of conservative fiduciary responsibility. It is for this reason the Board is recommending an increase in the annual assessment.

Your Voice Will Be Heard, And Your Vote Counted.

It is important to note that our recommendation to increase the non-ad valorem tax will not be made by the Board alone. This is a neighborhood decision. It will be decided by all of us—together. This is why we're asking for your input. On Monday April 11th at 6:30 p.m., the Carrollwood Recreation District will hold a public hearing at the Rec Center; the purpose of which is to consider placing a referendum on the August 23, 2022, public elections ballot proposing to change the annual assessment from \$600 to a cap of \$1,200 per year. If approved, the Board will raise the annual assessment as needed to meet budget projections.

What Happens If The District Becomes Insolvent?

If the Carrollwood Recreation District is unable to meet our financial obligations — as our financial projections forecast — the neighborhood parks and facilities would go into disrepair and amenities could close.

In The Past, Increases Were Done Incrementally Over A Course Of Years. If This Referendum Is Approved, The Board Plans To Take A Similar Course Of Action.

Approving this referendum on August 23 will help ensure the future financial stability of Original Carrollwood and will add the funds needed to enhance the neighborhood and the facilities that we already enjoy.

We look forward to hearing from you on April 11th and discussing the future of the neighborhood we love.
