What will the ballot say?

BALLOT LANGUAGE:

Changing the Carrollwood Recreation District Tax

Maximum Annual Assessment

BALLOT SUMMARY

Should the maximum annual amount of the Carrollwood Recreation District Tax, a non-ad valorem annual assessment imposed on each individual improved residential parcel located within the boundaries of the Carrollwood Recreation District, be changed from the current maximum of \$600 per year to a revised maximum of \$1,200 per year?

We strive to keep everyone informed about the upcoming vote on the neighborhood Preservation Assessment Adjustment. Each month, we will recap the basic points and update you with any new developments. Our monthly CRD Board Meetings are open to all, and neighborhood feedback is welcomed.

OC Neighborhood Assessment Adjustment

The key points

- Residents will vote during the August 23rd primary public election. A simple majority of YES votes is needed to pass the adjustment.
- The last time the assessment was increased, the Board raised it in small increments over 20 years. This CRD Board intends to do the same and will only increase to \$800.00 now.
- The purpose is to fund needed maintenance and preserve our neighborhood amenities.

The truth about the Assessment Adjustment

MYTH: The Board intends to raise the assessment to \$1200.00 immediately.

REALITY: The Board intends to raise the assessment to \$800.00 immediately. Current projections indicate that the CRD would remain solvent with this small incremental adjustment.

MYTH: There will be no major changes if the increase is not approved.

REALITY: IF the CRD operates at a deficit and is unable to remain financially solvent, there is a possibility that control over the properties could revert to Hillsborough County; thus, making our amenities public parks. On April 22, 2022, Florida Governor DeSantis signed legislation dissolving 6-special taxing districts.

MYTH: The current income is enough to keep the parks and neighborhood in good condition.

REALITY: On average, inflation cuts your buying power in half every twenty years. This same issue effects our budget as costs to maintain properties increase with inflation.

MYTH: The assessment adjustment is to fund major improvements to parks and the recreation center.

REALITY: The purpose of this adjustment is to enable the District to afford ongoing expense and maintenance to the neighborhood, and most importantly, to remain financially solvent.


"THIS IS A BIG DEAL!" Chamberlain Principal Jake Russell Recognized as One of State's Top Principals

Directions:

- 1. Heat the oven to 400 degrees. Cover a large, heavy-duty rimmed baking sheet with parchment. Remove the puff pastry from the refrigerator and let it come to room temperature while you prepare the toppings.
- 2. In a large nonstick skillet, heat the olive oil over medium heat. Add the asparagus, salami, scallions, and ½ teaspoon salt. Turn the heat to medium high.
- 3. Cook, stirring just occasionally for a minute or so, then frequently, until the asparagus are bright green and just beginning to take on color and the onions have softened a bit, a total of 4 to 5 minutes. (Remember these ingredients will be going into the oven, so you're just cooking them lightly.) Transfer the vegetables from the pan to a sheet pan or large plate; spread out to cool slightly.
- 4. In a medium mixing bowl, whisk together the egg and cream. Add the ricotta, the ½ cup Parmigiano, 2 teaspoons of the herbs, lemon zest, ½ teaspoon kosher salt, and several grinds of pepper. Set aside. [or use herb cream cheese]
- 5. Dust a rolling surface with all-purpose flour. Roll out the puff pastry into a rectangle about 14 inches long and 10 or 11 inches wide. Transfer to the baking sheet.
- 6.Use a fork to prick holes, spaced about a half-inch apart, all over the pastry.
- 7. Use a silicone spatula to spread the ricotta mixture over the surface of the dough. Spoon and scatter the sautéed asparagus mixture over the ricotta, spacing things out as best you can. Sprinkle the remaining few tablespoons of Parmigiano over the top.
- 8. Bake, rotating the sheet pan back to front once during cooking, until the pastry is puffed and golden, about 25 minutes.
- 9.Let cool for 10 to 15 minutes, garnish with herb leaves, and cut into slices to serve warm.

Ingredients:

- 1 sheet frozen puff pastry (about 8½ ounces), thawed overnight in the refrigerator
- 1 Tablespoon olive oil
- 8 ounces trimmed asparagus (about 12 to 14 ounces before trimming), sliced thinly on the bias into 2-inch pieces
- 1½ ounces bacon sliced to bitesized pieces
- 4 to 5 large scallions very thickly sliced (white parts only)
- Kosher salt
- 1 large egg
- 1 cup ricotta (not skim)
- ½ cup plus 2 to 3 Tablespoons coarsely grated Parmigiano
- 2 to 3 teaspoons finely chopped tarragon or mint, plus whole leaves for garnish
- 1/2 teaspoon (packed) freshly grated lemon zest
- Fresh pepper
- All-purpose flour for dusting

Other days he needs some encouragement, a treat, some Pup-peroni, or high-pitched human cue. Jimmy is a puppy in training with the Guide Dog Foundation, learning the basics of dog obedience.

Our family moved to Original Carrollwood in 2020 after finding a rental that fit our family. Almost instantly, we fell in love with the neighborhood. We knew we wanted to put our roots down here and were fortunate enough to be able to purchase a home in the OC last year. Our 5-year-old Labrador, Gus, has moved from rental to rental with us and we talked about getting him a friend once we purchased a home. Night after night, Kacey would be on Instagram and Facebook scrolling through pictures of cute puppies



doing silly things. With some thought and discussion, we filled out applications to raise a puppy for service. This felt right for our family as my wife and I both work in fields that serve others. We have a long history with Labs as pets and we have volunteered for the Labrador Retriever Rescue of Florida.

We went to Valdosta, Georgia, to pick up Jimmy, a Labrador Retriever from the Guide Dog Foundation. After spending 14-18 months with us learning basic obedience and

getting accustomed to as many different environments and situations as possible; Jimmy will go in for official guide dog training in New York. There they will see if he has what it takes to be a guide for a blind companion. Jimmy could also be placed into service with American VetDogs, a partner charity that provides service animals to help enhance veterans' independence and mobility. If neither works out, then Jimmy will surely make a great pet dog...usually the puppy raisers get the first opportunity to bring him back into the family.

When you see Jimmy in his yellow vest, give him a waive and a word of encouragement and know that he is working hard to become a great companion to someone in need. Mickey Jaap, Community Serviceman Extraordinaire

ickey Jaap, Original Carrollwood resident, has lived in OC in the same house since October 1991, being the third owner of this home. The Jaap family has fully embraced the Original Carrollwood life.

Mickey's wife, Meg, has lived in Original Carrollwood her entire life and her father, now in his late 80s, still lives in OC. When Mickey and Meg married, Meg gave options of where they could live ~ ~ ~ the north side of OC, the south side of OC, the east side of OC, or the west side of OC!

Mickey had ma already determined he and definitely wanted to live for in this extraordinary co first visit to Original Carrollwood was about five years prior to meeting Meg. While visiting OC on Christmas Eve and observing how festive the neighborhood was, he thought to himself, "I would like to live here one day."

Mickey and Meg raised three children (Ben, Bo, and Maggie) in this neighborhood. "The kids loved growing up across from the park, and they were out there weekend after weekend," Mickey reminisced. "Then they got into the beach and waterskiing." Mickey bragged that his son has caught the second largest bass in the Lake!

"This is such a unique community with the parades and events. We've always been really into it," says Mickey. "We've all won something one time or another at the 4th of July or Halloween parades." One year, Mickey converted a fourwheeled scooter into a space shuttle and Maggie, his daughter, dressed up in her outfit from the Kennedy Space Center. "She really loved that," said Mickey. "Now that the kids are grown, we mostly watch the parades instead of participate in them."

Mickey served on both the CCA and the CRD Boards twice each. He first served on the CRD for 3 years, then the CCA Board for seven years, then 3-4 years on the CRD Board before his final two years on the CCA Board.

Mickey tells us that a couple of the biggest accomplishments during his time on the Board included "the traffic calming project, perhaps to the dismay of

some of the residents. There was no headway with the County until the CCA got involved. Another big moment was when 8 or 9 people ran for election to the Board, surprising the then-current Board. Big changes were made. This new Board refinanced and reduced the debt by \$40K per year. Many kudos go to Cary Brown for his involvement in that," says Mickey. "Reducing the debt payments in 2014 freed up a lot of money for improvements." And Mickey adds, "The most fun part was going out for a good 'ole Americanstyle beer after Board meetings."


Mickey strongly encourages every resident to get involved in the Community, run for a seat on the Board, learn the rich history of OC and appreciate the uniqueness it holds. Adding, "The rights that the neighborhood have to the lake, the parks and the ability to keep them private is a fragile privilege. There are many things that threaten this privilege: An increase in traffic, some construction, and outsiders trying to make the parks public."

Mickey suggests each resident learn the laws and rules that govern the CCA and CRD. One of many informative examples from Mickey, "The CCA is a private entity, not a homeowner's association. The CCA owns the land in Original Carrollwood. The CCA rents that land to the CRD, which is a special taxing district formed in 1972 to maintain OC community parks, White Sands Beach, and facilities such as the Rec Center."

Further defining, Mickey says, the "CCA is NOT a committee of the CRD. They are two completely separate entities that function independently but work together for the good of the neighborhood." But to operate as designed, they must operate independently.

HISTORY:

The State of Florida deeded property to the Orange Belt 7 Railroad Company in 1888. When the railroad decided where to place the tracks, the title of the remaining land was passed in pieces to farmers, landowners and businessmen. Part of that land is now the submerged section of Lake Carroll and White Sands Beach. "Owning a lake bottom is rare, and this is another privilege that requires diligent maintenance." Enter Matt Jetton, the developer of OC.

Let's understand the difference between a Tax District and an HOA. The HOA is generally run by a Board chosen by the community and that board can choose to raise your fees at any time and generally with very little restriction. Often the members of these Boards are overzealous in their actions creating problems which

Help Maintain the Health of Lake Carroll **Keep pollutants out of storm drains!**

Pollution carried through stormwater runoff is one of the largest threats to urban water bodies. Nearly 900,000 acres of Florida lakes have been classified as impaired for recreation or aquatic life, mostly caused by urban/agricultural runoff. Currently, Original Carrollwood does not possess a comprehensive stormwater filtration system, so anything that finds its way into the storm drains will flow into Lake Carroll in a matter of minutes. Excess nutrients, largely through fertilizer runoff, and high bacterial loads through stormwater runoff, can impair the lake.

Bacterial Contamination

Bacteria are common in lake systems, but can become dangerous if certain types are present in large quantities.
